## IMPORTANT SAFETY BULLETIN

The following is a copy of a memo sent out by J&J Amusements last year. Please be aware this is a serious safety problem. Every operator needs to make certain that all Go-Kart attendants are aware of this.

**Sept 29, 1994**

**LONG HAIR IS A SAFETY PROBLEM  
SAFETY DECALS FREE!**

ALTHOUGH THE J&J GO-KART PROCEDURE MANUAL SPECIFICALLY POINTS OUT THAT ALL PERSONS WITH HAIR LONGER THAN SHOULDER LENGTH OR WITH ITEMS OF LOOSE CLOTHING MUST HAVE THESE ITEMS SECURED IT SEEMS THAT OPERATORS ALLOW THIS RULE TO LAPSE. RECENT PROBLEMS WITH LONG HAIR GETTING CAUGHT IN THE WORKS OF THE KART POWER TRAIN HAVE ONCE AGAIN DRAWN ATTENTION TO THIS MATTER. THE POWER TRAIN OF THE KART IS IN CLOSE PROXIMITY TO THE DRIVER, SIMPLY REACHING OUT OF THE KART BODY AND SLIGHTLY TO THE REAR YOU CAN EASILY TOUCH THE REAR WHEEL! ATTENDANTS MUST CONSTANTLY BE ON THE ALERT FOR LOOSE CLOTHING ITEMS SUCH AS DRAW STRINGS OR SCARVES. **HAIR LONGER THAN SHOULDER LENGTH MUST BE SECURED ABOVE SHOULDER LENGTH, RUBBER BANDS ETC. SHOULD BE PROVIDED FOR THIS PURPOSE AND SHOULD THE PERSON REFUSE THEY MUST NOT BE ALLOWED TO OPERATE THE KART.** CONSIDER THE SCENARIO OF HAVING ONE OF YOUR PATRONS LITERALLY "SNATCHED BALD" AFTER GETTING THEIR WAIST LENGTH HAIR CAUGHT UP IN THE TURNING AXLE OF THE GO-KART. SIGNS ARE CURRENTLY BEING MADE UP BY J&J FOR THIS PARTICULAR PROBLEM, (NOW AVAILABLE) CALL THE PARTS DEPARTMENT AND ORDER YOURS NOW.

ALL NEW J&J GO-KARTS HAVE A WARNING DECAL ATTACHED THAT ADDRESSES THIS ISSUE AS WELL AS OTHERS, TO OBTAIN THESE DECALS **FREE OF CHARGE** SIMPLY ASK THE PARTS DEPARTMENT TO SEND YOU THE QTY NEEDED.
